Following the Pledge of Allegiance, the Chair reported that a copy of the Nebraska Open Meetings Act had been posted in the rear of the room.

### Agenda Item 1e — Recording of Notice of Public Meeting

The Chair then reported on the recording of the Notice of Public Meeting and stated the following:

The notice of the meeting stated that an agenda for this meeting, kept continually current, was available for public inspection at the principal office of the Board of Governors, Building No. 30, 30th and Fort Streets, Omaha, Nebraska, by making prior arrangements by calling 531-622-2415.

Without objection, the Chair of the Board ordered that the affidavits be attached to the minutes of the meeting and made a part of the official proceedings of the Board of Governors.

## Agenda Item 3 — Public Hearing and Budget Action Agenda Items

Agenda Item 3a — Consideration of Resolution Approving an Additional 1% Restricted Funds Authority and Carryforward to Future Years, *Board Doc.* 8052

**BE IT RESOLVED** that, pursuant to Neb. Rev. Stat. Section 13-519(2), the Board of Governors of the Metropolitan Community College Area hereby authorizes and approves exceeding the limit set forth in Neb. Rev. Stat. Section 13-519(1)(a) for the fiscal year beginning July 1, 2024, and ending June 30, 2025, by an additional 1%.

**BE IT FURTHER RESOLVED** that the amount corresponding to said additional 1% shall be carried forward as unused restricted funds authority to be used in future budget years as determined by the Board of Governors in accordance with applicable law.

**BE IT FURTHER RESOLVED** that the budget statement for the College Area for fiscal year beginning July 1, 2024, and ending June 30, 2025, as finally adopted, shall incorporate and reflect all matters authorized and approved by this resolution. Prior to filing and certifying the adopted budget statement of the College Area, the Secretary or Assistant Secretary of the Board shall be authorized to make such adjustments to the adopted budget statement and take such other actions as are necessary or appropriate to carry out the actions approved herein.

The Chair explained that approval of the additional 1% authority pursuant to Neb.Rev.Stat. 13-519(2) requires the affirmative vote of at least 75% of the governing body. Seventy-five percent of the College's 11 Board members is 8.25, so nine votes are required to reach the 75% of the Board of Governors.

Monahan continued to explain that this item is for the Board of Governors to consider approving an additional 1% restricted funds authority and carryforward to future years.

Schmailzl asked Dave Hohman, external legal counsel to the Board, to further explain the 1% funds.

Hohman stated this is the first of four budget related resolutions on the agenda tonight. This first resolution would enable the College to reserve an additional 1% of restricted budget authority this year in the event the Board needs to use such budget authority in future years, as is provided for the Neb. Rev. Stat. 13-519(2). This action is not directly related to funding this year's budget. Rather, it gives the College an additional 1% of budget authority to carry forward for use in future years if the statutory lid on community colleges requires the Board to use such reserved budget authority in future years. The Board has often considered and approved the additional 1% of restricted budget authority carryforward in prior years. This resolution requires nine votes to pass, which would require the affirmative vote of all Board members present this evening. Are there any questions?

Hearing no questions, the Chair called for a motion and second to approve an additional 1% restricted funds authority and carryforward to future years.

The Chair explained that this agenda item is for the Board of Governors to consider amendments to the proposed MCCA Board of Governors Budget Statement for 2024-25. She asked president Schmailzl to explain further.

Schmailzl noted that the budget proposed in July 2024 was the best possible estimate available for the general fund revenue, which includes state aid, tuition and fees and miscellaneous income. Tonight, this budget statement needs to be amended because the figures changed in August and September. He referenced the state aid allocation, which is related to enrollment growth. The College received \$730,190 more than estimated, making the amended proposed budget \$144,495,194. This was due in part to summer enrollment.

Property tax for the general fund is zero and is not reflected in the budget this year.

The capital fund levy held steady at 2 cents and the general fund levy decreased 7.5 cents to zero.

The chair requested a motion and second to approve the resolution.

BE IT RESOLVED, that the Board of Governors of the Metropolitan Community College Area does hereby approve the Budget Statement identified as MCCA Board Doc. No. 8044a for the fiscal year beginning July 1, 2024, and ending June 30, 2025, as amended, including restricted funds, and the amount of unused restricted funds authority carried forward to future budget years necessary to preserve total restricted funds authority, as set forth in 2024-25 CC Budget Form, (the permissible additional 1% restricted funds authority per Nebraska Statutes Section 13-519(2) was considered and approved by separate resolution with the affirmative vote of at least 75% of the Board of Governors), and that the Secretary or Assistant Secretary of the Metropolitan Community College Area of the Board be, and hereby is, authorized and directed to certify a copy of said Budget Statement, attach copies of the Proofs of Publication of the Notices of Hearing thereon, and file same, together with the amount to be received from personal and real property taxation to fund the Budget, with the Boards of Equalization of Dodge, Douglas, Sarpy, and Washington Counties, Nebraska, on or before September 30, 2024, and with the Auditor of Public Accounts of the State of Nebraska; and

BE IT FURTHER RESOLVED, that the Board of Governors of the Metropolitan Community College Area does hereby set at \$21,654,826.22 the amount of tax required to fund the Budget Statement and the amount to be received from personal and real property taxation, and that of such tax requirement, \$0.00 shall be the amount levied for payment of principal and interest on bonds issued or authorized to be issued by the College Area and \$21,654,826.22 shall be the amount levied for all other purposes, and further that the Secretary or Assistant Secretary of the Metropolitan Community College Area of the Board be and hereby is authorized and directed to file with and certify those tax requirements to the Boards of Equalization of Dodge, Douglas, Sarpy, and Washington Counties, Nebraska, on or before September 30, 2024, and file the same with the Auditor of Public Accounts of the State of Nebraska; and

BE IT FURTHER RESOLVED, that the Board of Governors of the Metropolitan Community College Area does hereby set the tax levy for said Area for its fiscal year beginning July 1, 2024, and ending June 30, 2025, at 2.0 cents per hundred dollars on the taxable valuation of all property subject to the levy within the Area; and, further, that 0.00 cents of said total tax levy shall be for the purpose of supporting operating expenditures of the Metropolitan Community College Area or other permissible purposes authorized by Neb. Rev. Stat. Section 85-1517(2)(a) and 2.00 cents of said total tax levy shall be for the purpose of establishing a capital improvement fund and bond sinking fund or for other permissible purposes authorized by Neb. Rev. Stat. Section 85-1517(2)(b); and further that the Secretary or Assistant Secretary of the Metropolitan Community College Area be, and hereby is authorized and directed to certify to and file a copy of these resolutions with the

County Clerks and Boards of Equalization of Dodge, Douglas, Sarpy, and Washington Counties, Nebraska, and with the Auditor of Public Accounts of the State of Nebraska; and

BE IT FURTHER RESOLVED, that certified taxable values as provided by the County Assessors pursuant to Neb. Rev. Stat. Section 13-509 shall be used in setting or certifying the tax levy. The Board of Governors of the Metropolitan Community College Area hereby authorizes and directs the Secretary or Assistant Secretary of the Board, prior to certifying the levy to the respective Clerks and Boards of Equalization of the four counties within the College Area, to review, or cause to be reviewed, the certified valuations to determine that they do not vary sufficiently from the valuations used by the Board so as to require a levy of a different amount in order to raise the amount stated in the Board's Adopted Budget Statement—2024-25 to be raised by taxation, and if such a variance does exist, to adjust the Board's levy so that the Board's levy is consistent with certified valuations; and

**BE IT FURTHER RESOLVED**, that the Board of Governors of the Metropolitan Community College Area does hereby authorize and direct a designated member of the Board of Governors, or its representative, to appear and present the approved budget at the hearing of any represented county which requests in writing such an appearance and presentation; and

**BE IT FURTHER RESOLVED**, that the Secretary or Assistant Secretary of the Board is hereby authorized to direct and to take such other actions as necessary or appropriate to carry out budget-related Resolutions approved or unapproved at this meeting of the Board of Governors in accordance with applicable law.

The chair explained that this item is for the Board of Governors to consider adopting the Proposed MCCA Board of Governors' budget statement for 2024-25, as amended, approving the amount of property tax required to fund the budget, and setting the property tax levy for 2024-25, including levy for the amount of property taxes for capital improvements.

The Chair called for a motion and second to approve the resolution.

- (a) The name of the political subdivision: Metropolitan Community College Area (MCCA);
- (b) The amount of the property tax request for fiscal year 2024-25: \$21,654,826.22;
- (c) The following statements:
  - (i) The total assessed value of property differs from last year's total assessed value by 8.77% percent;
  - (ii) The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.087342 per \$100 of assessed value;
  - (iii) The Metropolitan Community College Area proposes to adopt a property tax request that will cause its tax rate to be \$.02 per \$100 of assessed value; and
  - (iv) Based on the proposed property tax request and changes in other revenue, the total operating budget of Metropolitan Community College Area will exceed (increase) last year's budget by 3.3%.

BE IT FURTHER RESOLVED that, after notice and special public hearing as required by law, the Board of Governors of the MCCA does hereby set the final property tax request for the MCCA for fiscal year 2024-25 in the amount of \$21,654,826.22 pursuant to Neb. Rev. Stat. §77-1632 of the Property Tax Request Act (Neb. Rev. Stat. §§77-1630 through 77-1634). Such request as set herein shall not exceed the request for fiscal year 2023-24 and shall override any deemed request or adjustment pursuant to the Property Tax Request Act.

**BE IT FURTHER RESOLVED**, that the Board of Governors does hereby authorize and direct the Secretary or Assistant Secretary of the Board to certify and forward this resolution to the County Clerks of Dodge, Douglas, Sarpy, and Washington Counties, Nebraska, on or before October 15, 2024.

## Agenda Item 4a — Ex Officio Board Members' Report

## Student Ex Officio Representative Report

Zulu highlighted the upcoming Student Advisory Council 14<sup>th</sup> Annual Leadership Conference to be held on October 11, 2024. She noted SAC members had created centerpieces and worked on supporting documents for the conference and said it would be a 70's theme.

#### Faculty Ex Officio Representative Report

Pechacek introduced Cathy Brunkhorst, dean of transfer; Bhaswati Manish, biology instructor and Alaina Buchanan, biology instructor, who presented on SEA-PHAGES. Brunkhorst explained the program is a research project in the biology department and noted the work of Mike Flesch, project coordinator, in getting the project started.

The team defined SEA-PHAGES: science education alliance-phage hunters advancing genomics and evolutionary science. The Howard Hughes Medical Institute selected MCC as a program partner in 2023. The program is taught in two quarters with the first course being a virus discovery class and the second class is a phage bioinformatics class. MCC was the first community college in Nebraska to offer this program. MCC students have discovered 11 novel phages.

The team acknowledged and thanked the MCC Foundation for their support, which allowed students to attend conferences and receive scholarships.

Some of the students in these classes have been high school students. A student from Ralston High School was a top six winner in the Senior Metropolitan Science and Engineering Fair in 2024.

Questions from the Board included clarification that the program is a general education class. Brunkhorst noted that they are working on the transferability of the classes with other institutions of higher education. Reinhardt asked for an explanation of a virus as something other than a disease. PHAGES actually eat bacteria and are useful for humans in the field of antibody resistance and in agriculture. In the US about 200 colleges have similar programs and about 30 of those are community colleges. MCC is the only community college in Nebraska with these kinds of classes. In response to a question from Wright, the team noted that environmental soil samples are used to discover varieties of bacteria. Brunkhorst noted that the program is currently being reviewed by the University of Nebraska Omaha in regard to transferability.

Brunkhorst emphasized the value for students to have research experience on their college applications and resumes.

## Agenda 4b — Chair of the Board's Report

Monahan referenced the preparation work for the Association of Community College Trustees Leadership Congress is going well and she has been impressed again on the success of the re-entry student restaurant, Ooh de Lally, thanks to the vision of staff and assistance from community benefactors.

#### Agenda 4c — Board Members' Reports

Uhe thanked Schmailzl and others for their work in Lincoln in reducing property tax, acknowledging the passing of the budget earlier in the meeting.

He also noted the success he had with the new iFixOmaha program at the Fort Omaha Campus as they repaired an iPad for him.

## Agenda 4d — President's Report

Schmailzl said the next step in the final approval of the fourth MCC campus, Sarpy County Campus, is going to the Coordinating Commission for Postsecondary Education (CCPE) in October for formal approval. He stated the last college campus to be approved in Nebraska was 60 years ago.

He noted the need for the state's community colleges to submit a proposal for the Fiscal Year 2025-27 Biennium Budget. The three funding mechanisms are: (1) the Community

College Future Fund; (2) the Community College Aid Act; and (3) separate appropriations to fund dual enrollment course offerings for high school-aged students.

The Community College Future Fund provides distributions to community college areas in lieu of colleges levying general fund property taxes. MCC will receive an automatic 3.5% increase annually. This figure may be increased based on enrollment growth, which, for MCC, was 8 percent this past year.

The Community College Aid Act (*Neb. Rev. Stat. § 85-2234*) is the state's contribution to support community college general fund budgets. These annual allocations are distributed per an established formula. Community colleges requested 3.5% increase in state aid to account for growing enrollments and increased operating costs.

Dual Enrollment has been supported by the state's American Rescue Plan Act (ARPA) for the past three years, allowing high school students to take college-level classes for free or with greatly reduced tuition. ARPA dollars end in June 2025. Requests for additional dual enrollment funds will go through due process in the Nebraska legislature with the support of many Nebraska senators, K-12 educators and parents. Schmailzl noted that MCC has the highest dual enrollment numbers in the state. Bruckner stated she believes dual enrollment changes lives.

Schmailzl thanked the Board for their support with the budget process and noted that the four counties in the MCC area are the largest in the state and two of our counties bring in the most income and sales taxes in the state of Nebraska. The community colleges were able to lower taxes this year.

Assistant Director of Foundation Accounting – The Assistant Director performs accounting and analysis functions for the Foundation in accordance with generally accepted accounting principles (GAAP).
