# **Respiratory Therapy**

Metropolitan Community College offers an Associate of Applied Science Degree in Respiratory Therapy. Successful completion of the Respiratory Therapy program prepares graduates to sit for national exams through the NBRC and obtain state licenses for practice. \*Some states may require additional education to obtain a state license; students should contact the licensure board for specific requirements.

The two-year program provides classroom instruction, lab experience and clinical practice to prepare students for work in a variety of health care environments throughout the community.

Applicants who are not admitted but wish to be considered for future admission must submit a new application packet.

The Respiratory Therapy program does not accept advanced placement, prior respiratory education or work experience in lieu of required program course work.

#### **Admission Criteria**

Final admission to the Respiratory Therapy program will be based on receipt of a completed background check, abuse registry check and drug screening. Details regarding these tests will be given upon acceptance to the program.

Students in the Respiratory Therapy program will be required to show documentation of a physical examination along with records of required immunizations. They must also complete a CPR course for health care providers. Details will be provided upon formal acceptance to the program.

## **Program Admission Process**

• Applicants are required to take an <u>entrance exam</u> as part of the application process for the Respiratory Therapy program. An appointment must be made for the exam at one of the College's Campus Testing Center locations.

- In order to utilize credits transferred from other institutions, official transcripts MUST be submitted and fully evaluated by the MCC Records office prior to the application deadline. Transcript evaluation can take four to six weeks to process upon receipt.
- Only courses with a C or higher, will be counted (with the most recent grade used).
- All admission requirements and the program application must be completed prior to the application deadline.
- The Respiratory Therapy program grants admission to 21 students each academic year. Since it is normal that more applications are received than available seats for the class, applicants will be ranked according to the following factors:
- 1. Applicants will receive **one point** for each of the following courses they have completed or transferred to MCC with a grade of C or higher, with the most recent grade used:

2. Applicants will receive **two points** for each of the following courses they have completed or transferred to MCC with a grade of C or higher, with the most recent grade used:

- BIOS 1310 Survey of Human Anatomy & Physiology
- 3. COMS 1300 Interpersonal Communication and PHYS 1010 Applied Physics will be taken after formal acceptance into the Respiratory Therapy program, so no application points will be given for these courses.
- 4. The applicant's grade point average (GPA) as of June 1 for the above listed program degree requirements will be multiplied by **three** to provide a numeric point value.
- 5. The applicant's overall score on the entrance exam will be converted to a scale of 10 and multiplied by **two** to arrive at a numeric point value for the exam.
  - (i.e., score of 82 converted to 8.2, multiplied by 2, equals 16.4 points). The entrance exam is limited to three attempts in a two-year period.
- 6. After June 1 of each year, the total numeric points of each applicant will be calculated. Applicants will be notified of admission by U.S. mail.
- 7. Final formal acceptance to the program will be based on satisfactory completion of the background checks, abuse registry and drug screening.

All course grades must be a C or higher (this includes General Education and Other Course Requirements).

### RESPIRATORY THERAPY TECHNICAL STANDARDS VALIDATION

All health care students are required to meet definite standards for the profession and for practical performance. Upon acceptance into one of the aforementioned courses/programs, students will be expected to sign the following document validating their ability to meet the stated requirements.

The following are specific requirements of all students:

- Ability to stand, sit, walk, push and squat
- Ability to lift and/or carry 50 pounds
- Ability to reach in forward, lateral and overhead motions
- Ability to climb stairs
- Ability to distinguish distance, colors, objects and persons
- Ability to demonstrate depth perception
- Ability to hear conversation, monitor equipment, perform auscultation, use a telephone and distinguish background noise
- · Ability to distinguish sharp/dull and hot/cold
- Ability to perform fine and gross motor skills with both hands
- · Ability to think clearly and calmly in stressful situations
- Ability to communicate effectively, verbally and in writing, using appropriate grammar, spelling and vocabulary
- · Ability to work cooperatively with others
